

DIGITAL MILLENNIUM COPYRIGHT ACT (DMCA) POLICY

1. PURPOSE

Husband On Demand LLC ("HOD," "Company," "we," "our") respects the intellectual property rights of others and expects all users of the Platform to do the same.

This Digital Millennium Copyright Act ("DMCA") Policy explains how copyright owners may submit claims of copyright infringement and how HOD responds to such claims in accordance with the Digital Millennium Copyright Act (17 U.S.C. §512).

2. MARKETPLACE STATUS

HOD operates solely as an online technology marketplace connecting Customers with independent Service Providers.

Users—not HOD—are solely responsible for the content they upload, publish, transmit, or otherwise make available through the Platform.

Nothing in this Policy shall be interpreted as creating a duty for HOD to proactively monitor user content.

3. COPYRIGHT OWNERS

If you believe that material available through the Platform infringes your copyright, you may submit a written DMCA Notice to our Designated Copyright Agent.

False or misleading notices may expose the sender to liability under applicable law.

4. DMCA NOTICE REQUIREMENTS

Your notice must include all of the following:

A.

Your full legal name.

B.

Your mailing address.

C.

Your telephone number.

D.

Your email address.

E.

Identification of the copyrighted work claimed to have been infringed.

If multiple works are involved, you may provide a representative list.

F.

Identification of the allegedly infringing material.

Please include sufficient information to allow us to locate the material, including:

- URL
- Screenshot
- User profile
- Job listing
- Photograph
- Review
- Other identifying information

G.

A statement that you have a good-faith belief that the disputed use is not authorized by:

- the copyright owner;
- the copyright owner's agent; or
- the law.

H.

A statement that the information contained in the notice is accurate.

I.

A statement made under penalty of perjury that you are the copyright owner or authorized to act on behalf of the owner.

J.

Your physical or electronic signature.

5. DESIGNATED COPYRIGHT AGENT

6. COMPANY RESPONSE

Upon receiving a valid DMCA Notice, HOD may:

- remove the allegedly infringing material;
- disable access to the material;
- notify the user who uploaded the material;
- request additional information;
- preserve records as required by law.

HOD reserves the right to reject notices that do not substantially comply with the DMCA.

7. COUNTER-NOTIFICATION

If you believe your content was removed by mistake or misidentification, you may submit a Counter-Notification.

Your Counter-Notification must include:

Your full legal name.

Your mailing address.

Telephone number.

Email address.

Identification of the removed material.

The location where the material appeared before removal.

A statement under penalty of perjury that you believe the material was removed as a result of mistake or misidentification.

A statement consenting to the jurisdiction of the Federal District Court:

- where your address is located; or
- if outside the United States, any judicial district in which HOD may be found.

Your physical or electronic signature.

8. COMPANY ACTION FOLLOWING A COUNTER-NOTIFICATION

Upon receiving a valid Counter-Notification, HOD may:

Forward the Counter-Notification to the original complainant.

Restore the removed material if permitted by law.

Maintain removal if legal proceedings are initiated.

Nothing in this Policy requires HOD to restore any content.

9. REPEAT COPYRIGHT INFRINGERS

HOD maintains a policy for addressing repeat copyright infringement.

Users who repeatedly violate copyrights may have their accounts:

- suspended;
- permanently terminated;

- restricted.

The Company retains sole discretion in determining whether repeated violations have occurred.

10. FALSE CLAIMS

Submitting knowingly false DMCA Notices or Counter-Notifications may expose the sender to civil liability under the DMCA and other applicable laws.

HOD reserves the right to pursue any legal remedies available.

11. USER RESPONSIBILITY

Users remain solely responsible for ensuring that they have the legal right to upload or use:

- photographs;
- videos;
- logos;
- artwork;
- music;
- text;
- trademarks;
- other copyrighted material.

Users agree not to upload content that infringes the intellectual property rights of others.

12. NO DUTY TO MONITOR

To the fullest extent permitted by law:

HOD has no obligation to:

- review all uploaded content;
- monitor user activity for infringement;
- investigate every allegation of infringement.

The Company may remove content at its sole discretion if it believes removal is appropriate or required by law.

13. LIMITATION OF LIABILITY

Nothing in this Policy creates any obligation for HOD to determine ownership of intellectual property.

To the fullest extent permitted by law:

HOD shall not be liable for:

- user-uploaded content;
- copyright disputes between users;
- delays in responding to notices;
- removal or restoration of content performed in good faith under the DMCA.

Nothing in this section limits liability that cannot legally be excluded.

14. PRESERVATION OF SAFE HARBOR

HOD intends to qualify for the safe harbor protections provided by 17 U.S.C. §512.

Nothing in this Policy shall be interpreted as waiving any rights, defenses, immunities, or statutory protections available under federal or state law.

15. MODIFICATIONS

HOD may revise this Policy at any time.

Updated versions will be posted on the Platform with a revised Effective Date.

Continued use of the Platform constitutes acceptance of the revised Policy.

16. GOVERNING LAW

This Policy shall be governed by the laws of the United States and the State of Florida,

without regard to conflict-of-law principles.
